## **ADD JOINT SUBSCRIBER - RESIDENTIAL**

# Article I Section 2 of the Cooperative's bylaws provides: SECTION 2. Joint Membership.

(a) A husband and wife, or any two persons who occupy the same household, may apply for a joint membership and, subject to their compliance with the requirements set forth in Section 1 of this Article, may be accepted for such membership. The term "member" as used in these bylaws shall be deemed to include a husband and wife or any two persons who occupy the same household holding a joint membership, and any provisions relating to the rights and liabilities of membership shall apply equally with respect to the holders of a joint membership. Each joint member shall be jointly and severally bound by the Articles of Incorporation, bylaws, rules, regulations and tariff of the Cooperative, as such may be amended from time to time. Without limiting the generality of the foregoing, the effect of the following specified actions by or in respect of the holders of a joint membership shall be as follows:

- i. the presence at a meeting of either or both shall be regarded as the presence of one member and shall constitute a joint waiver of notice of the meeting;
- ii. the vote of either separately or both jointly shall constitute one joint vote;
- iii. a waiver of notice signed by either or both shall constitute a joint waiver;
- iv. notice to either shall constitute notice to both;
- v. expulsion of either shall terminate the joint membership;
- vi. withdrawal of either shall terminate the joint membership;
- vii. either but not both may be elected or appointed as an officer or director, provided that both meet the qualifications for such office.

By signing this Application, both the original subscriber and the joint membership applicant certify to the Cooperative that they qualify for a joint membership under the bylaws, and agree to be jointly and severally liable for all charges that accrue for services rendered after the date of this application.

#### SERVICE AGREEMENT

The applicants certify that they are the owners/lessees/tenants of the premises where service is applied for with the lawful authority to sign this application for telephone service and agree to pay the applicable rates and abide by all conditions as prescribed by the Arctic Slope Telephone Association Cooperative, Inc. All costs incurred by Arctic Slope Telephone Association Cooperative, Inc. for the collection of any unpaid accounts shall be paid by the applicants. All terms and conditions of the agreement with the original subscriber are incorporated herein by this reference.

It is understood that upon presentation, this application becomes the property of Arctic Slope Telephone Association Cooperative, Inc. We also certify that we are each eighteen (18) years of age or older.

Your signatures in the designated locations authorize Arctic Slope Telephone Association Cooperative, Inc. to conduct credit checks in order to determine possible deposit requirements. A photocopy of these signatures will be considered authorized signatures.

### **ASTAC TERMS AND CONDITIONS**

1. ASTAC'S HOME INTERNET10 IS BILLED WITH A MONTHLY REOCCURING ACCESS FEE OF \$24.99 AND TOTAL AMOUNT BILLED IS BASED ON USAGE. VARIABLE RATE FEES ARE: \$2.00 PER GB UP TO 100GB AND \$1.00 PER GB FOR EVERY GB USED AFTER 101GB. THIS IS A VARIABLE RATE BASED ON USAGE AND IS IN ADDITION TO THE MONTHLY BILLING TOTAL LISTED ABOVE. THE MONTHLY ACCESS FEE IS INCLUDED IN THE MONTHLY BILLING TOTAL ABOVE.

2. ASTAC'S RESIDENTIAL SERVICES REQUIRE A 1-YEAR COMMITMENT THAT IS SUBJECT TO A \$300 TERMINATION FEE IF SERVICES ARE TERMINATED PRIOR TO THE 1-YEAR COMMITMENT.

3. ASTAC'S WIRELESS SERVICES REQUIRE A 1-YEAR COMMITMENT THAT IS SUBJECT TO A \$200 TERMINATION FEE PER LINE IF SERVICES ARE TERMINATED PRIOR TO THE 1-YEAR COMMITMENT.

 THIS AGREEMENT ALSO SERVES AS A DEVICE FINANCE AGREEMENT FOR ANY WIRELESS DEVICES FINANCED THROUGH ASTAC. ALL TERMS OUTLINED WITHIN THE "EQUIPMENT OVERVIEW" SECTION ARE SEPARATE AGREEMENTS FROM THE 1-YEAR COMMITMENT AND MUST BE PAID IN FULL IF SERVICES ARE TERMINATED.
