



Starlink Equipment Definition:

Required Starlink equipment for buyback:

- Starlink Base (Satellite Dish) **REQUIRED**
- Router **REQUIRED**
- 50FT Starlink Cable **PREFERRED**
- 6FT AC Cable **PREFERRED**

1. Eligibility:

- This discount promotion is available to all customers of ASTAC who are considered good standing and surrender the required Starlink Equipment with proper proof of Starlink account in members' name.
- Customers must meet all eligibility requirements and agree to and abide by these terms and conditions to participate. Eligibility requirements are as follows:
 - 24-Month contract is required to participate in the Starlink Equipment Buy Back promotion.
 - Once the equipment is surrendered, along with proof of a Starlink account with member name on it, a \$500 bill credit will be issued.
 - Failure to fulfill the signed 24-month commitment will result in a \$500 termination fee.

2. Promotion Details:

- The promotion offers a one-time discount of \$500.00 applied to the account level.
- If the account the discount is applied is in a past due status, the account must have an active payment arrangement.
- If the payment arrangement is defaulted on, the account will forfeit its credit and the account will be disconnected in non-pay, resulting in the contract not being honored.
- This promotion is subject to availability and may be subject to additional terms and conditions set by ASTAC.
- ASTAC's contract terms and conditions supersede the promotional terms and conditions.
- ASTAC reserves the right to end this promotion without notice.
- Buy Back Discount eligibility is separate from eligibility for the new Starter, Enhanced, Premium, and Elite Residential Internet Plans.

3. Activation and Subscription:

- To participate in the promotion, customers must surrender their Starlink Equipment and provide proof of member name on Starlink account during the promotional period.
- Customers must meet all requirements for activation and subscription as determined by ASTAC and its service agreement.

4. Duration and Renewal:

- The promotional discount is a one-time discount.
- After the promotional credit has been absorbed by existing or future monthly invoice charges, the monthly fee will revert to the regular price as specified in the service agreement, unless otherwise stated.

5. Limitations and Exclusions:

- This discount can only be received if proper equipment has been surrendered to ASTAC along with proof of a Starlink account with your name on it.
- ASTAC is not responsible for terminating your service with Starlink. Surrendering your equipment is only an exchange for an ASTAC bill credit.
- ASTAC will not return your equipment if your credit is forfeited due to breach of contract. Once the equipment has been surrendered, you will not be able to obtain access to it at a future date for any reason.
- This discount is only available to active ASTAC members.
- This discount cannot be issued to a customer in check form at any point in time; the credit is intended to be used for ASTAC services or forfeited to the company if not used in full.

6. Termination and Cancellation:

- ASTAC reserves the right to modify, cancel, or terminate the promotion at any time, for any reason, without prior notice.
- In the event of a customer's violation of the service agreement or any fraudulent activity, ASTAC may terminate the promotion and the customer's subscription.
- Failure to keep your account in good standing may result in termination of your account and a termination fee of \$500.00 being applied to your account.
